St. Andrew's United Methodist Church COVENANT STATEMENT AND VOLUNTEER APPLICATION FOR CHILDREN'S AND YOUTH MINISTRIES

The congregation of St. Andrew's United Methodist Church is committed to providing a safe and secure environment for all children, youth, at risk individuals and volunteers who participate in ministries and activities sponsored by the church. The following policy statements reflect our congregation's commitment to preserving this church as a holy place of safety and protection for all who would enter and as a place in which all people can experience the love of God through relationships with others.

- 1. No adult who has been convicted of child abuse (either sexual abuse, physical abuse, or emotional abuse) should volunteer to work with children, youth or at risk individuals in any church sponsored activity.
- 2. All adult lead volunteers involved with children, youth or at risk individuals of our church must have been members of the congregation or is personally known to the ministry leader for at least six months before beginning a volunteer assignment.
- 3. Adult volunteers with children, youth or at risk individuals should observe the "Two-Adult Rule" at all times so that no adult is ever alone with children, youth or at risk individuals.
- Adult volunteers with children, youth or at risk individuals shall attend regular training and
 Educational events provided by the church to keep volunteers informed of church policies and state laws
 regarding child abuse.
- 5. Adult volunteers shall immediately report to their supervisor any behavior that seems abusive or inappropriate.
